

Support Zone One: Foundations

This section covers everything that a youth theatre should have in order to run legally and be governed well. If you find that you don't have everything in place or you are a new youth theatre, please don't panic.

Support Zone Two: Policy and Access

Keeping up with policy can be challenging for youth theatres when under-resourced and pushed for time. This **Zone** provides guidance on what policies and procedures you should have in place and how to make youth theatre as accessible as possible.

Support Zone Three: Your Team

Youth theatres in Scotland come in all different shapes and sizes but one thing that they all have in common is that they involve people. Whether that is a team of two or twenty-two, in this **Zone** YTAS has collated guidance for best practice when working with others.

Support Zone Four: Business Development and Fundraising

This **Zone** covers: business planning, managing money, marketing, fundraising, evaluation, and sustainability. YTAS knows that some of these areas can be the hardest to keep up with when under pressure, and hopes to alleviate some of this pressure through providing guidance and useful tools to support these areas.

2. Choosing a Structure

It's worth doing your research when choosing or changing the structure of your youth theatre. The structure is about how you will operate. Firstly, you must decide whether your youth theatre will be incorporated or unincorporated.

These are some popular options in Scotland:

- Scottish Charitable Incorporated Organisation (SCIO)
- · Company Limited by Guarantee
- Voluntary Association
- Community Interest Company (CiC)
- Unincorporated organisation

Choosing to be a charity is not choosing a structure. From you research, decide what you think will work best for your youth theatre and then choose a structure accordingly. It may change in the future but be mindful that some structures are more straightforward to change than others so choose carefully. Please visit the following for guidance:




4. Fundraising

Leaders of small charities or CICs often struggle to get to fundraising because of having so much to do and not knowing where to start. As a YTAS member you can access resources from **Truffle Pig's** Grant Writing Toolkit, which is made up of quick, practical training and worksheets to help with the nitty-gritty of raising more money for your group. We've added some resources within this section, and will keep adding more.

First things first though... start with a plan! No two fundraising plans will be the same. Many organisations don't have one, they just fire out applications here, there, and everywhere and see what sticks. It is always best to have a plan. It will streamline your process and likely boost your success rate. You can always deviate from it when unexpected opportunities arise but even then, refer to it and your business plan to see if the fund or investor aligns with your mission, aims and values.

As a YTAS member, you should start with some of the Truffle Pig videos below, and work through them as you go on your fundraising journey. Their **Identify Your Most Fundable Idea** module goes alongside the videos, and will help if you feel pulled between multiple great ideas deserving of funding and just want the confidence to know what application to work on first.
